- 2. I acknowledge the inherent risks involved in any sport/activity while at the campsite and choose to engage in voluntarily. I assume full responsibility for any personal injury to myself and (if applicable) my child, and further release the organization for injury, loss, or damage arising out of my or my child's use of or presence upon the facilities of the organization.
- 3. I understand that the management of the Campsite disclaims responsibility for any accidents, damage to property, theft, fire accidents (including bushfires), or drowning in fishponds due to the following reasons:
 - Activities such as hiking, mountain biking, and rock climbing are undertaken at my own risk.
 - Road access may be challenging and is not controlled by the Campsite.
 - Despite the absence of resident big game, the Campsite is located in a Game Management Area (GMA), and wildlife may pass through.
 - o There is a presence of snakes and other dangerous small wildlife, insects and bees.
 - All activities in general are undertaken with inherent risks.
 - Access to fishponds is permitted only under adult supervision, and there is a risk of drowning.

- 4. I acknowledge that I am responsible for my own safety and well-being during my stay at the Campsite.
- 5. For family groups with children under the age of 18, I consent and also sign on behalf of my children, ensuring that this form has been well understood.
- 6. In the event of an emergency, I authorize the organization to secure emergency medical care or transportation (i.e., EMS) for myself or my child. I agree to assume all costs of emergency medical care and transportation.
